AIBHILIN, taken to rate, angled off the inside three furlongs out, edged closer behind rivals near the five sixteenths marker, swung four wide into the lane, responded when set down past the three sixteenths marker, closed determinedly and got up at the wire. HOT SQUEEZE sprinted clear early, set a solid pace towards the rail while under rating, remained clear under urging past the eighth pole, met bids in deep stretch, battled gamely and just could not hold. PURE LADY LIKE moved up between runners early then dropped to the rail to track the pace, altered out in upper stretch, gave hard pursuit past the furlong grounds and finished gamely between the top pair. KOMBAT CAT was steadied when in close through the opening sixteenth off a mile, dropped well off the early pace, slipped through along the rail nearing the furlong marker and finished with good energy. COUNTRY SUNSHINE lacked speed, came four to five wide for the drive and closed willingly. FANCY BOSS was shuffled back soon after the break, carried wide into the turn, circled four wide, angled out in upper stretch and came up empty. NEW ZONE drifted in some early, chased three wide to upper stretch and gave way. CHASE MY TAIL broke slowly, was sent up between rivals nearing the turn, angled in, shifted back out for the stretch run but lacked a rally. WEEKENDS FOR LOVE steadied and got out a bit into the turn, angled in and gave way. INSPIRED SAY EYE was lightly steadied early, rushed up between foes, chased four wide and faltered.
