GORMLEY angled in and stalked inside, split horses leaving the second turn and into the stretch, drifted in some in the drive and was edged for the show. STONE HANDS chased between horses then off the rail on the second turn, continued outside a foe into the stretch and weakened. CISTRON sent along to the early lead, set a pressured pace inside, fought back midway on the second turn, dropped back nearing the guarter pole and had little left for the stretch.
