Purse \$200,000 (Includes \$50,000 BC - Breeders' Cup) SHIRLEY JONES H.(GRADE II) FOR FILLIES AND MARES, FOUR YEAR OLDS AND UPWARD.** By subscription of \$200 each by Wednesday March 12,2008, which shall accompany the nomination, \$1,500 to pass the entry box and \$1,500 additional to start, with \$150,000 Guaranteed and an additional \$50,000 from the Breeders' Cup Fund for cup nominees. The host association Monies to be divided, 60% to the owner of the winner, 20% to second, 11% to third, 6% to fourth, 3% to fifth. Breeders' Cup monies not awarded will revert back to the fund Weights: Mond ay, March 17, 2008. This race will not be divided. The field will be limited to 14 starters. If more than 14 entries pass the entry box, the starters will be determined at the time with the preference given to Breeders' Cup Nominees only equal racing qual ity horse or weight assignment. Starters to be named through the entry box on Wednesday March 26,2008 by the usual time of closing. Trophy to winning Owner given by Breeders' Cup Ltd. (High Weights Preferred). All fees shall be paid prior to the start off the race. Nominations closed Wednesday, March 12, 2008 with 17 Nominations. (Clear 80)
