For horses not originally nominated, a supplemental payment of \$2,000 along with the entry and starting fees may be made at any time prior to the publication of weights. The purse to be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally amongst the remaining finishers. A trophy will be presented to the winning owner. Closed Saturday, July 15, 2017 with 10 Nominations. (Clear 78)

PAID UP SUBSCRIBER bumped lightly at the start by TERRA PROMESSA who broke in a step, raced just off the inside through the opening bend before settling four wide down the backstretch unhurried and in range of the leader, began to close in in tandem with APOLOGYNOTACCEPTED from the nine-sixteenths latching on to TERRA PROMESSA as a team, advanced stacked three wide to take over command seven-sixteenths from home, sauntered away in hand through the latter portion of the far turn and came under light coaxing briefly swinging three wide for home, opened up widening away and went clear in hand through to the finish to prevail very comfortably at the end. TERRA PROMESSA broke in a step at the start bumping lightly with PAID UP SUBSCRIBER, raced three then two wide through the first turn taking over command midway on that bend and showing the way under a tight grip just off the inside down the backstretch through solid splits, had the tracking pair range up and latch on outside with nine-sixteenths to go, tucked to the inside half a mile from home put to light coaxing, got headed at the seven-sixteenths, came under encouragement three furlongs from home, swung five wide into upper stretch proving no match for the top one while battling it out to preserve the place honors, shook that rival off inside the eighth pole finishing leg weary at the end. APOLOGYNOTACCEPTED coaxed from the gate lightly, led early on along the inside until displaced from command by the aforementioned foe midway on that bend, settled three wide down the backstretch in range of the leader, advanced in tandem with PAID UP SUBSCRIBER to latch on with nine-sixteenths to go, came under coaxing five furlongs out and raced between foes until shaken off at the seven-sixteenths, came under a drive at the three-eighths, went six wide at the quarter pole and battled with the aforementioned foe through to the eighth pole before weakening to the wire leg weary.
