7 FURLONGS. (1.20) STAKES. Purse \$100,000 SLEEPY HOLLOW S. FOR TWO YEAR OLDS FOAMED IN NEW YORK STATE AND APPROVED BY THE NEW YORK STATE-BRED REGISTRY. No nomination fee. A supplemental nomination fee of \$1,000 may be made at time of entry. \$500 to pass the entry box and an additional \$500 to start. All starters including supplements will be required to pay both entry and starting fees. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. 122 lbs. Non-winners of \$50,000 allowed 3 lbs.; a Sweepstake; or two races, 5 lbs.; a race, 7 lbs.; maidens, 9 lbs. (Maiden and claiming races not considered). A trophy will be presented to the winning owner. Closed Saturday, October 9, 2010 with 27 nominations. (Cloudy 62)

Gray or Roan Colt, (Feb), by Tapit - Empty the Bases by Grand Slam. Trainer Jenkins Rodney. Bred by New Dawn Thoroughbreds & Aron Yagoda(NY).

BANDBOX stumbled at the break, was taken in hand and allowed to settle into stride, bided time along the outside down the backstretch, entered the turn from the three path, was taken out more path coming to the three-eighths pole, circled past rivals with an effortless four wide sweep to reach a good striking position by the quarter pole, was let out a notch after entering the stretch, remained under some urging until midstretch, took over just past the eighth pole, then edged clear, completing the race under the mildest of hand rides. LUXURY APPEAL patiently tracked the leader from the inside, was angled outward in the vicinity of the five-sixteenths pole, in preparation for the stretch drive, was called upon turning for home, then displayed a good kick en route for the place. CREA'S LAW was taken off the rail coming to the half mile pole, swung wide into the stretch, settling to be about six wide at the top of the lane, then rallied belatedly to earn the show. NEVER RIGHT JOEY three wide most of the way around turn, was set down in upper stretch and rallied willingly to gain the last major share. BAMBI BOUND stumbled at the start, chased the leader three wide, gained the lead after turning for home, only to weaken steadily after leaving the furlong grounds. PRIVATE RULES coaxed along while taking the inside route early, advanced steadily into contention after entering the lane, but could not sustain the bid during the final eighth. BOUND BY HUMOR had a wide journey and tired. HYSTERICAL CAT stumbled at the start, contested the pace along the outside until the quarter pole and gave way. OUR BRAVE WARRIOR vied from the inside and faltered.
