FLAT OUT unhurried early, asked a bid into the far turn, accelerated and challenged four wide into the stretch, leveled off and finished up well in a sharp effort to win ridden out. SILVER BAYER set or forced the pace along the inside, continued to vie past the furlong marker, proved no match for the winner late, clear for the place. GRESHAM off the pace, moved a bit closer while inside of foes and toward the rail late in the final turn, flattened out a bit to report home best of the rest. BERTSGOLDENMISSILE vied up front three wide, weakened in the drive. PROCEED BEE off a bit slow, trailed for six furlongs, angled out slightly and steadied a bit late in the final turn, improved only slightly when clear in the drive along the inside. NINTH CLIENT with the pace, four wide both turns, tired. PROFESSOR Z narrowly set the pace while between foes, gave way in the drive.
