

# **ELEVENTH RACE** **Gulfstream Park** **July 5th, 2015**

6 FURLONGS. (1:08<sup>4</sup>) STAKES. Purse \$250,000 Smile Sprint S.THREE YEAR OLDS AND UPWARD. Any horse that has participated in a race at Gulfstream Park since December 6, 2014, will be charged no fees to enter or start. All other horses shall pay \$2,500 to pass the entry box and \$1,000 additional to start, with \$250,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: Three Year Olds 120 lbs; Older 123 lbs. Non-winners of a grade I stakes since January 1 allowed 2 lbs.; a grade II or \$60,000 twice since January 1, 4 lbs.; a sweepstakes since January 1, 6 lbs. Supplemental nominations are made at the time of entry. All horses that are nominated or supplemented may be subjected to out of competition testing prior to the running of the race. Closed Sunday, June 21, 2015 with 29 nominations. (Hazy 91)

**Bay Gelding, (Mar), by Tale of the Cat - Tricky Elaine by Grindstone. Trainer Guadalupe Preciado. Bred by Paul Conaway (PA ).**

FAVORITE TALE took the lead shortly after the start, continued on top throughout the backstretch, felt oncoming pressure at the five sixteenths pole, caught for more, responded, fought off rivals and pulled away. WORK ALL WEEK placed up close just off the top two leaders along the outside, edged up closer at the quarter pole, dug in for rival in the turn, continued bid for eventual winner into deep stretch, could not catch rival and settled for second best. WILDCAT RED hustled up and raced just off FAVORITE TALE, continued bid just off rival into the upper stretch, raced within contention and yielded in the final furlong. GRANDE SHORES was a bit slow into stride at the start and continued off the early pace, made a move along the rail, gained ground and continued steady inside bid to the rail. ALSVID tracked the leaders along the rail, urged for response along the outside in the turn, dug in along the outside at the eighth pole and lacked needed kick to move forward. CITY OF WESTON was reserved near the back off the pack in early stages, made a move five wide in the turn, gained ground but needed more. LEDOKOL raced in the back of the field in the backstretch, urged for response along the inside at the head of the lane and failed to produce a needed rally. FALLING SKY broke through the gate and was held onto by the rider, was allowed to settled off early pace, urged for response approaching the quarter, failed to move on and finished evenly. SINGANOTHERSONG raced up close along the rail in early stages, urged for response at the five sixteenths pole, could not move on and gaveway in the lane.
