1 1/2 MILES. (Turf) (1.442) STAKES. Purse \$300,000 *SUNSHINE MILLIONS TURF S. FOR FOUR YEAR OLDS AND UPWARD, BRED IN CALIFORNIA OR FLORIDA AND REGISTERED WITH THE CTBA OR THE FTBOA.* By subscription of \$100 (Early Bird Nomination) if made on or before Thursday, December 17, 2009 or \$500 (Regular Nomination) if made on or before Saturday, January 16, 2010. \$6,000 supplementary Nominations are due at time of entry. All horses to pay \$1,500 to enter and \$1,500 to start with a guaranteed purse of \$300,000. The purse to be divided, 55% to first, 20% to second, 11% to third, 7% to fourth and 4% to fifth. The remaining 3% to be divided amongst the remaining finishers. Four-Year-Olds: 120 lbs.; Older: 122 lbs. All fees must be paid after entries are drawn or are subject to be scratched. A trophy will be presented to the winning owner. Closed Thursday, December 17, 2009 with 37 nominations. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile and One Eighth) (Rail at 108 feet). (Cloudy 78)

JET PROPULSION quickly moved to the fore, was uncontested while making the pace along the rail into the stretch, then was fully extended to hold sway. PICKAPOCKET tracked the pace three wide into the stretch, then rallied to prove second best. PICOU unhurried early, raced four wide around the far turn and closed with a mild response to be up for the show. SOLDIER'S DANCER allowed to settle, advanced into contention three wide around the far turn but didn't do enough late. TIE ROD tracked the pace along the inside, then was checked when unable to get through inside ROMAN TIGER leaving the far turn and failed to menace. BAD ACTION reserved off the pace, steadied in behind rivals on the first turn, was saving ground when steadied again in behind TIE ROD leaving the far turn and never threatened. ROMAN TIGER chased the winner to nearing the stretch, then tired. FEARLESS EAGLE rated off the pace, faltered leaving the far turn. BALLONENOSTRIKES was through after a half mile.
