SCOTT'S SPIRIT flashed good early foot while crossing over, dictated the pace

from the inside, lost command in upper stretch, weakened but held for minor award. OVERLAND reserved off the rail, continued on three wide

path into and around the second turn and finished willingly. WARRENS ATTACK CAT came in early while taken off the pace, later shifted out, caught four then five wide into the stretch and improved placing. ROSSO CORSA reserved early, chased along the rail into and through the stretch and never menaced. ROAR OF EAGLES four wide early, continued off the rail, swung out and caught six wide leaving the second turn and did not threaten. WAAFI between foes into the backstretch, remained bit off the rail and was no factor. NITRO ACTIVE stalked the leaders

from between foes before weakening. BERT'S LAW chased three wide early then four wide into the stretch and also weakened. STORM DRAGON dropped far back into and through the backstretch and was outrun.
