FASTEST MAGICIAN reserved off the pace, advanced along the inside to gain the place while no threat to the winner. NUMB LIPS unhurried early, saved ground and passed tired rivals to be up for the show. LIVE IN JOY set the pace along the rail into the stretch, then gave way. LIGHTHOUSE SOUND raced four wide and failed to menace. MOBILIZER was not a factor. FINAL COUNT stalked the pace three wide to midway of the far turn, then tired. FLAMIN' HOT rated off the pace, steadied in traffic on the far turn and faltered.
