R HEAT LIGHTNING lagged behind during the early stages, settled nicely into stride approaching the half mile pole, circled past rivals from the four path during the run around the bend, under mild encouragement, settled into the three path, having now been put to a drive, spinning into the stretch, closed in on the leader, wrested the lead in the vicinity of the sixteenth pole and edged clear under strong handling.

ALIENATION overcame a stumble at the break to assume a forward position, sat along the inside, just off the early pacesetter's hindquarters, firmly rated, zipped past that rival with a quick move at the nine-sixteenths pole, with the rider keeping something in reserve all the while, motored away to a sizeable advantage by the quarter pole, still only relying on her natural speed, was put to encouragement after turning for home, saw the lead dwindle down, attempted to stave off the top one as that rival arrived on the scene with a sixteenth remaining, failed, but continued on with good courage to garner place honors. VALIANT PASSION within range along the outside, was asked for a response at the five-sixteenths pole, but was outkicked. COAX LIBERTY three wide entering the turn, dropped over to the rail near the five-sixteenths pole, was called for run and tired. LE MI GEAUX four wide around the turn, was roused at the five-sixteenths pole but had no offering.

STOPSPENDINGMARIA coaxed along while tracking the front runners from the inside, gave way after going a half. ABIDE drifted out badly leaving the chute, appeared to be going uncomfortably until midpoint on the backstretch, continued to race wide and failed to reach a contending position. SKY HOSOYA lightly urged to grab the early lead, offered little resistance when displaced by the top one and faded.
