SIPPICAN HARBOR pinched in the shadow of the starting gate, was in path two racing towards the rear of the pack, was placed to a brisk hand ride approaching the quarter pole, swung wider and wider until in the path eight by the end of the maneuver, kicked into her best venturing up to the sixteenth pole, overhauled the front runners in the final seventy yards and drew off smartly. RESTLESS RIDER was sighted pulling on the bit spinning three to four wide onto the turn, got angled five wide for the drive home, rallied with some willingness to procure the place. CASSIES DREAMER away last after hitting the side of the gate, shifted from path two to path three from top of the turn to its midway point, angled into path six from upper to midlane, closed in well to secure the show. BELLA CIAO took up the chase from path four on the turn, was put to a prolonged drive at the three-eighths pole, challenged as the widest of three spinning into the lane, lugged in at the three-sixteenths pole, squeezing back CATHERINETHEGREAT, forged on ahead with good energy locked in a spirited head to head tussle with the leader, lugged in again from a steady application of the stick right handed as NONNA MADELINE was shifting to the outside herself, leading the twosome to bump into each in deep stretch, had no answer when the top one burst upon the scene soon afterwards and weakend. NONNA MADELINE shook off several light bumps right after the start to establish the top, showed the way coaxed along, with GUACAMOLE in accompaniment to the outside, saw it morph into a three-way fight when CATHERINETHEGREAT joined them on the turn, cut the corner with a pair in hot pursuit to her outside, began the final furlong under fire while clutching a narrow advantage, came out inside the sixteenth to meet up with a lugging in foe, resulting in a solid collision, weakened late. REFLECT reserved while mostly three wide on the turn, moved into path four in midstretch, made no late headway. CHASING YESTERDAY took up the chase from midpack after lightly bumping a few times with another, was guided from path three to path five during the first half of the run around the bend, then went a couple of paths wider during the initial portion of the stretch, flattened out in the last sixteenth. VIRGINIA ELOISE briefly along the rail on the turn, got eased back into path two to slip by a fader midway on the turn, paused in hand coming up to the end of the bend, stepped into the stretch and had no rally. CATHERINETHEGREAT lightly hand urged on the chute, ranged up in path three to contest the pace as the widest of three starting at the half mile pole, challenged in earnest between rivals spinning into the stretch, got squeezed in the general area of the three-sixteenths pole from pressure coming from an errant BELLA CIAO, was put to some light encouragement afterwards, but never regained interest. BABY NINA rushed up along the inside, was through after going a half, came into stretch then went down it nder a protective hold. GUACAMOLE came in slightly after losing her footing springing from the starting gate, was pulled away and corrected, thus avoiding becoming mixed up a bumping incident going on at the time, assumed a prominent position, was coaxed in path two disputing the pace, was forced to undergo the task from between rivals once CATHERINETHEGREAT arrived on the scene past the half mile pole, continued on with it for a little while longer before backing away, spun into the lane and went down it placed to a protective hold, Following a Stewards' Inquiry focusing on BELLA CIAO in the stretch, the result was allowed to stand and the race was declared official.
