GOT LUCKY tucked in to save ground, took closer order through the second turn, got through every step, shifted out for the final furlong, quickened and was up in the shadow of the wire. UNTAPABLE tracked the pace between horses, moved up to engage the leaders nearing the seven-sixteenths pole, poked her head in front a furlong out, fought on valiantly but was denied in the final strides. YAHILWA disputed the pace two wide, was collared between horses, dug in gamely and battled doggedly but wasn't quite good enough. FRIVOLOUS settled in hand, advanced between horses through the second turn in step with the winner, tipped out four wide entering the stretch, but flattened in the final furlong. LOVELY MARIA contested the pace along the inside to the final furlong and wilted. TIZ WINDY attended the pace toward the inside, shifted out four wide on the second turn, but came up empty entering the lane and faded. FLASHY AMERICAN was unhurried into stride, lagged at the tail of the field and was never a factor. MEI LING contended four wide for six furlongs and retreated. DIVA'S DIAMOND was hustled along five wide for a half and dropped out.
