MARQUEE PRINCE vied for the lead while inside, was in a long drive then weakened in late stretch. EPIC DREAMER was settled while inside on the backstretch, made a bid and was four wide in upper stretch, was bumped in mid stretch and steadied then came up empty in late stretch. D TOZ was unhurried early then rallied six wide on the far turn making a bid then flattened out in the drive. KAZIRANGA was allowed to settled then saved ground on the far turn then was inside in the stretch and was no menace.
