RUSSELL ROAD stalked the pace two deep, assumed a slim advantage near the three sixteenths pole, dueled clear midstretch and widened under steady handling. BEWARE OF THE BOP rated a short lead inside, was pressured at the rail through the final turn and remained a close factor to the sixteenth pole before yielding. NAY'S TAP settled off the early pace inside, eased four wide making a bid past the three eighths pole, had aim three wide at the top of the stretch but leveled off the remainder. PAGAN CAT rated off the pace inside, eased outward on the final turn and flattened stride in the lane. CHIEF OSHKOSH, unhurried off the rail, had no rally. DARTH TATER stalked the pace three wide, gave chase toward the final turn but had no further response in the turn. GABRIEL'S SMILE never factored. RAGGEDY ANDY, never a factor, bled and was vanned off post race.
