Supplementary nominations may be made by closing time of entries at a fee of \$3,000 which qualifies to start with \$75,000 Guaranteed and an additional \$25,000 from the Breeders' Cup Fund for CUP ELIGIBLES ONLY. The Host Association's monies divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. Breeders' Cup Fund monies also correspondingly divided providing a Bre eders' Cup nominee has finished in an award position. Any Breeders' Cup Fund monies not awarded will revert back to the Fund. TAKEDOWN outrun early while off the inside, came four wide into the lane, roused, finished well to be in time. HARROW LAND forwardly placed inside, boxed in far turn while continuing along the rail, boxed in second turn, moved out a bit, lacked room past the furlong marker until a sixteenth remained, split foes late and finished willingly. SPEEDWAY moved up to vie for the lead on the outside, showed the way past the furlong marker, gave ground grudgingly. RUN ALEX RUN allowed the pace to go early, joined the leaders three wide turning for home, did not have enough in the late going. ST. ZARB cleared to the inside late in the first turn, set or forced the pace, weakened. MR. SOUL four wide into the stretch, failed to rally. SUMAC was not involved. FRONT COURT finished, was done early.
