Supplemental nominations of \$1,500 will be accepted at time of entry which shall include all fees. \$60,000 Guaranteed of which 60% to the winner; 20% to second, 11% to third, 6% to fourth h, 3% to fifth. Weight: 122 lbs. Non-winners of \$36,000 allowed 2 lbs. \$25,000 allowed 4 lbs. \$20,000 allowed 6 lbs.(Maiden and claiming races not considered in estimating allowances). Starters to be named through the entry box by the usual time of closing. (Winners Preferred) This Stake will be limited to 14 starters should race not be split. Preference to horses that have accumulated the highest lifetime earnings. Different owners have equal draw according to money earned. Second choice high earners of a same owner entry receive no consideration over a single entry. Failure to draw into the race will cancel all fees. The owner of the winner to receive a trophy. Closed Saturday, December 6, 2008, with 26 nominations. (Cloudy 75)

ASK JOE unhurried early, eased in going to the turn, was eased out nearing the drive, rallied mid track and got up. BIG PUSH clear early, was headed by VALID STRIPES turning for home, fought back from along the inside, but was outfinished. VALID STRIPES forwardly placed four wide, bid outside BIG PUSH nearing the drive, gained the edge, then did not have enough late. CITIZEN stalked BIG PUSH early, tried hard but lacked a rally. MAP OF THE WORLD raced wide and could make little impact. NORTHERN PRINCE inside early, moved around DOC'S FRIEND midway around the turn, then lacked a finish. SPECIAL HEART inside to nearing the drive, angled out and improved position. IT HAPPENED AGAIN was no real threat. MERKEL bobbled and swerved in at the break, then was no threat. DOC'S FRIEND forwardly placed along the inside early, retreated. SCREEN YOUR FRIEND between foes early, broke down inside the final sixteenth and was vanned off.
