6 FURLONGS. (1:08) STAKES. Purse \$75,000 Sugar Bowl S. FOR TWO YEAR OLDS. Free nomination by Saturday, December 8. \$375 to enter; \$375 additional to start. Supplemental nominations of \$1,500 will be accepted at time of entry which shall include all fees. \$75,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to finishers sixth through ninth. Weight: 122 lbs. Non-winners of \$36,000 allowed 2 lbs, \$25,000 allowed 4 lbs, \$18,000 allowed 6 lbs (Maiden and claiming races not considered in estimating allowances). Starters to be named through the entry box by the usual time of closing. The Sugar Bowl Stakes will be limited to fourteen (14) starters. Preference will be given in the following manner: graded or group winners in order (I, II, III), then highest lifetime earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee or supplementary nomination fee if applicable. A trophy will be presented to the winning owner. Nominations Closed Saturday, December 8, 2018 with 22 nominations. (Clear 60)

GRAY ATTEMPT sprinted clear at once, saved ground while setting the pace, responded when set down for the drive and held sway to the wire. MANNY WAH was reserved just off the leaders early, raced three-wide through the turn, could not reach the winner in the drive but finished with a steady bid. HOG CREEK HUSTLE was off a step slow then allowed to settle, raced four-wide through the turn, reached a contending position into the stretch but lacked the needed late response. SUPER STEED showed no early speed, raced three-wide through the turn, angled out further into the stretch and finished with some late run. ASSEMBLYMAN lacked early foot, raced five-wide through the turn and finished evenly late. CAJUN FIRECRACKER broke sharply to chase the winner from between foes and weakened after going a half. UNCAPPED was void of early speed, raced three-wide through the turn and failed to rally. SOVEREIGN IMPACT was forwardly placed from the inside and weakened after going a half.
