&Marjac Farms(KY). CHITU broke sharply to stalk the pace of GAREN from the outside, moved up in tandem with MIDNIGHT HAWK to offer a bid nearing the five-sixteenths pole, vied with that rival into mid-stretch and drew off through the final yards. MIDNIGHT HAWK also race just off the leaders in

a stalking position from the outside, moved up with the winner nearing the five-sixteenths marker, gained a brief lead but could not match

strides with that rival through the final furlong. COMMISSIONER bobbled at the break, raced unhurried early, moved outside through the second turn, could not gain on the top pair in the drive but finished with some late interest. REBRANDED was taken back soon after the start, raced wide through both turns, reached a contending position approaching the stretch but lacked the needed closing response. BOURBONIZE

raced off the pacesetters throughout, moved far outside through the second turn and did not menace. GLOBAL STRIKE raced off the pacesetters from the inside and gradually weakened. GAREN sprinted clear soon after the start, saved ground while setting the pace and

weakened after going six furlongs. TANZANITE CAT chased the leaders from the outside for a half and weakened. LAWLY'S GOAL raced wide through both turns and did not reach contention.
