STRONG CONTENDER off a bit slow, second flight toward inside, asked along backstretch, asked for more second turn, moved out three wide, roused for the drive, responded, late bid, came together briefly with the runner up, proved best. **LAWYER RON** with the early pace off the inside, shook clear backstretch and moved down toward the inside, vied again in the second turn closest to the rail, garnered a daylight advantage once again nearing the furlong grounds, brushed slightly with the winner late and could not contain that foe, well clear of the rest. **LOUISBORG** fell back to trail after the start, began to move in the far turn, continued a steady advance into the stretch and was up for the show while not a threat to the top two. **COSTA RISING** vied up front through the first turn, fell back a bit off the pace, rejoined the fray up front in the second turn, faltered somewhat in the drive and was caught in the final strides for the show. **MAJESTIC STREAM** lacked speed, failed to make an impact in the drive. **HIS EYES** showed the way early along the inside, fell back then went back to the front between foes into the far turn, began to fade soon after. **POINT DETERMINED** off the early pace while outside, made a slight advance in the run up the backstretch to briefly race within striking distance, gave way soon after.
