I SPENT IT hustled from the start, was forced to check briefly at the nine-sixteenths bobbling when placed in tight between foes as BATTLE RED crossed to the two path into the turn, chased four wide in range through the turn, swung three wide for home, rallied with good kick to collar the front inside the sixteenth marker and prevailed inching away at the end. BATTLE RED hustled from the start, crossed to the two path into the turn placing I SPENT IT in tight briefly, cut solid splits under coaxing, got set down at the head of the stretch, edged away briefly under a drive to the eighth pole, ran on getting caught in the late stages while well clear of the rest for the place. EVOLUTION lunged slightly at the start, strode greenly early on two to three wide at the rear, came under urging three furlongs out, angled five wide for home, kicked on belatedly for the show honors. CAT FIFTYFIVE broke in a step at the start and was corrected, chased four wide coaxed along, cornered three to four wide into upper stretch, made no headway. MACHINATION chased just off the inside from mid pack, came under a ride three furlongs out, offered no response. ENJOY THE SHOW hustled from the gate, chased the pace three wide in aim, came under urging at the five-sixteenths, tired in the drive. DINNER TIME hustled from the start, strode a bit green early on while saving ground towards the rear, angled three wide into upper stretch, made no impact.
