1½ MILES. (Turf) (1.442) STAKES. Purse \$150,000 SUWANNEE RIVER S. (GRADE III) FOR FILLIES AND MARES, FOUR YEAR OLDS AND UPWARD. (\$15,000 bonus for FTBOA Registered Florida-Bred by an FTBOA Registered Florida Sire). Free Nomination, \$1,500 to pass the entry box and \$750 additional to start, with \$150,000 Guaranteed. The owner of the winner to receive \$90,000, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to sixth. All fees shall be paid prior to the start of the race. **Weights:** 123 lbs. Non-winners of a grade I or II at a mile or over on the turf since August 1, allowed 2 lbs.; of a graded stakes at a mile or over on the turf since April 1, 4 lbs.; \$45,000 at a mile or over on the turf since August 1, 6 lbs. In the event this stakes is taken off the turf, it may be subject to downgrading upon review of the Graded Stakes Committee. Trophy to the winning owner. Closed Saturday, January 25, 2014 with 29 Nominations. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile and One Eighth) (Rail at 96 feet). (Clear 80)

PARRANDA broke sharply to establish a narrow advantage along the rail racing to the first turn, dictated the pace on a narrow margin under light reserve through the backstretch, continued in that fashion into the second bend, was roused clear racing into upper stretch and held sway on a comfortable margin to the end under pressure. RIPOSTE (GB) broke slowly, was settled into stride along the rail, saved ground throughout while continuing under patient handling, then made solid late progress nearest the rail in late stages to secure the place honors. ABACO tracked just off the leaders in the opening stages, made steady advance to striking distance three deep racing into the far turn, was roused to challenge in that path in upper stretch but was outkicked. MALIBU YANKEE broke slowly, recovered quickly while angling to the inside to stalk just off the pacesetter under rating, was urged along the inside into upper stretch, couldn't gain terms with the winner but continued willingly between foes to the end while just missing for a share. CAROLINE THOMAS was rated three deep in the second flight tracking the leaders from just out of striking distance, shifted out four wide racing into the lane while being urged to advance but had no late bid. AINSLEY was rated between foes in the second flight tracking the leaders to the far turn but came up empty racing into upper stretch. ABBEY STREET angled in gaining terms with the eventual winner attending that foe's pace, prompted that foe midway through the backstretch, continued with a brief bid between foes on the far turn but emptied out racing into upper stretch. NICKI STARSHINE settled outside a rival in the opening stages, shifted out four wide nearing upper stretch, bobbled leaving the turn, was pulled up in upper stretch, then was vanned off the course.
