POINT DETERMINED prompted the pace outside A.P. WARRIOR, took a short advantage midway on the second turn, fought back inside the winner while drifting out and in from the whip through the stretch and continued willingly to the wire. A. P. WARRIOR sped to the early lead, set a pressured pace under a rating hold along the inside, fought back when headed midway on the second turn, dropped back leaving that turn and weakened in the stretch. POTENTIAL pulled his way along inside to stalk the pace, dropped back into the second turn, gave way and was not persevered with in the drive.
