WORLD APPROVAL perfect position to the turn, gained the lead in the stretch while confidently handled through the final sixteenth to prevail at the wire. **FORGE (GB)** well placed while never far back, rallied through the drive and was coming on late but settle to be second best. **FIRE AWAY** no speed to the far turn, swung widest and moved up in the late going. **TASIT** raced rank early and down the backstretch, swerved around fallen horse around the final turn and recovers to move up in the stretch run. **NOBLE THOUGHT** raced far back to the stretch and only improved position from the far turn. **LE KEN (ARG)** dueled along early, gained the lead and dueled into the far turn but could not go on and weakened. **WESTERN RESERVE** speed, dueled on the backstretch, led past the quarter pole but faded in the stretch. **CHEYENNE'S COLONEL** had no speed to far turn, fell over fallen horse around the final turn and unseated the rider. **DOCTOR MOUNTY** had good position to far turn with a mild move but fell abruptly in the turn and lost the rider.
