INNER TURF FOR FILLIES AND MARES THREE YEARS OLD AND UPWARD FOAL*ED IN NEW YORK STATE AND APPROVED BY THE NEW YORK STATE-BRED REGISTRY. No nomination fee. A supplemental nomination fee of \$1,000 may be paid at time of entry. \$600 to pass the entry box and an additional \$650 to start. All starters including supplements will be required to pay both entry and starting fees. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. Three year olds, 120 lbs. Older, 123 lbs. Turf weights: Non-winners of \$60,000 on the turf in 2010 allowed 2 lbs.; a sweepstake on the turf in 2010, 4 lbs.; three races on the turf, 6 lbs. Dirt weights: Non-winners of a sweepstake on the dirt in 2009-10 allowed 2 lbs.; \$30,000 on the dirt in 2009-10 or four races on the dirt, 4 lbs.; three races on the dirt, 6 lbs.(Maiden,claiming and starter races not considered in allowances). A trophy will be presented to the winning owner. The New York R acing Association reserves the right to transfer this race to the Main Track. Closed Saturday, October 9, 2010 with 29 Original Nominations and 1 Supplement. (Clear 62)

YOU GO WEST GIRL allowed to roll out of the starting gate under her own volition, was taken well hold of and eased towards the back of the pack, sat well reserved from there taking the inside route, continued to save ground, with the rider still conserving as much as energy as possible, before slipping outward in the vicinity of the five-sixteenths pole, fanned wide into the stretch, was stacked six wide at the head of the stretch before being commencing to rally, displayed a strong kick once given her cue, charged down the outside of the course with long strides, wrested command several jumps past the sixteenth marker and drew off under brisk hand encouragement. CHORUS MUSIC away in good order, was strung out four wide during the most of the run around the opening bend, proved to be somewhat headstrong, displaying, readily dragged the rider into the lead position once given some rein on the backstretch, was guided over to the inside once sufficiently clear, showed the way towards the inside, under a good hold, responded positively when finally released from the hold in upper stretch, failed to keep pace with the top one when that opponent arrived on the scene, but continued onward with good courage to secure second. EXCLUSIVE SCHEME the early leader, readily command to the runner up, content to track the new leader from the inside, bided her time until nearing the quarter pole, fought for the lead until midstretch, then was outkicked during the last eighth. AKILINA reserved along the outside until the half mile pole, was asked to pick up the pace, sat within good striking distance approaching the head of the lane, but lacking optimal racing clearance, turned for home, still stuck in traffic, kept pace as best as she could under light encouragement, during a stretch-long search for the necessary stretch, gained it a bit too late, flashing interest belatedly. MERIWETHER JESSICA rated stalking the leader, came up empty for the stretch run. CHESTORIA unhurried, came five wide into the stretch but lacked the needed kick. MS STILLETO forwardly placed throughout, was called upon in the vicinity of the five-sixteenths pole and tired. PARAIBA saved ground to no avail. CRAZY CATLADY three wide around the opening bend, tired. MY MAGIC MOMENT three wide around the first turn, was outrun.
