STELLA MARK tucked in behind dueling leaders into the turn, shifted out approaching stretch, advanced three wide into the lane, attacked inside rivals, reached the front passing sixteenth marker and pulled away. COST OF FREEDOM dueed or set pressured pace from along the rail, resisted in the drive but could not contain winner in final sixteenth. MEDZENDEEKRON was slow into stride, reserved outside foe, remained on same path into the stretch and gamely gained minor award. JOHNNY EVES forced or dueed outside rival into and around the turn, lacked needed punch in the drive then lost third late. DAKOTA PADRE stalked outside winner, caught three then four wide into the stretch and lacked needed late punch. NOTIONAL reserved while slightly off the fence, gained the rail into and through the stretch but failed to threaten.
