LEAH'S SECRET sat patiently parked off the leaders while travelling in the four path, took off after the leaders when set down in upper stretch, drew along side SLEWFOUNDMONEY at the furlong marker, forged her way to the front with seventy yards remaining and edged away under a drive. SLEWFOUNDMONEY contested the pace while racing three wide, shook free after turning for home, came under attack from the top one soon afterwards, dug in stubbornly, surrendered with seventy yards to go but continued on with good courage to be a clear second. BOCA GRANDE devoid of early foot, gained steadily during the stretch run to grab the show. SO GLITZY saved ground until the eighth pole and held well to the wire. ALTESSE lacked the necessary stretch response. ANY LIMIT vied for the lead while kept off the inside, gave way after entering the stretch. SHINING IMAGE stumbled at the start, was forwardly placed while four wide around the turn, had nothing left to offer after going a half. RITE MOMENT took the overland route, was urged on the turn and folded.
