1 $\frac{1}{2}$ MILES. (Turf) (1.40¹) STAKES. Purse \$100,000 *TRANSYLVANIA S. (GRADE III)* FOR THREE YEAR OLDS. By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 at time of entry (includes entry and starting fees). \$500 to enter and an additional \$500 to start, with \$100,000 guaranteed, of which \$60,000 to the owner of the winner, \$20,000 to second, \$10,000 to third, \$5,000 to fourth, \$3,000 to fifth and \$2,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of \$60,000 at a mile or over on the turf allowed 3 lbs.; \$45,000 at a mile or over on the turf, 5 lbs. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the owner of the winner. Closed Wednesday, March 28, 2012 with 29 nominations. In the event that this race is taken off the turf it will be contested at One Mile and One-Sixteenth on the main track. (Clear 62)

SILVER MAX sped clear to dictate terms and remained unchallenged. TRAVEL ADVISORY was unhurried into stride, settled saving ground, angled out leaving the second turn, drifted in under right handed pressure, but kept on well between rivals and clearly proved second best. STATE OF PLAY contended along the inside, got through entering the stretch but lacked the needed late response. MONASTIC settled under a snug hold three wide, shifted out five wide leaving the second turn, offered a mild bid but failed to sustain the drive. ICON IKE hopped at the start, moved up three wide to attend the pace, but faltered in the final furlong and faded. WAYWARD SAILOR settled saving ground, tipped out entering the stretch, was put in tight when TRAVEL ADVISORY came in near the furlong marker, steadied and lost all chance.
