**1 $\frac{1}{2}$  MILES. (1.404) (Off The Turf) STAKES.** Purse \$100,000 **TRANSYLVANIA S. FOR THREE YEAR OLDS.** By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 at time of entry (includes entry and starting fees). \$500 to enter and an additional \$500 to start, with \$100,000 guaranteed, of which \$60,000 to the owner of the winner, \$20,000 to second, \$10,000 to third, \$5,000 to fourth, \$3,000 to fifth and \$2,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of \$60,000 at a mile or over on the turf allow ed 3 lbs.; \$45,000 at a mile or over on the turf, 5 lbs. The maximum number of starters for the Transylvania will be limited to fourteen with two also eligibles. In the event that more than fourteen pass the entry box, the fourteen starters will be determined at that time with preference to graded stakes winners (in order I-II-III), then highest turf earnings. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner. Closed Wednesday, March 19, 2014 with 46 nominations. In the event that this race is taken off the turf it will be contested at One Mile and One-Sixteenth on the main track. (Showery 62)

**MEDAL COUNT** settled toward the inside, ranged into striking position through the second turn, slipped through along the inside entering the stretch, came to level terms with **PICOZZA** a furlong out and gamely edged clear. The latter settled in hand, made a sweeping move five wide, loomed large entering the stretch, but was out kicked. **WOODFIELD SPRINGS** was allowed to settle, advanced between rivals through the second turn, tipped out six wide entering the stretch and was making up ground well. **STORMING INTI** was close up four wide, but flattened between horses in the final furlong and gave way. **LADDIE BOY** contested the pace three wide through the second turn, but faltered between horses entering the stretch and faded. **HESINFRONT** contended between horses for six furlongs and retreated. **GLOBAL VIEW** lagged at the tail of the field and was never a factor. **KODY WITH A K** broke awkwardly, rushed to the lead, disputed the pace along the inside to the second turn, stopped and was eased to the wire but walked off.
