E Z'S GENTLEMAN broke in a bit, saved ground stalking the pace, bid along the rail into and on the turn, took a short lead in upper stretch, inched away in midstretch and drew clear under urging. SANGAREE stalked outside then three deep on the backstretch and turn, came four wide into the stretch and held off a rival for the place. GAYEGO was in a good position just off the rail then stalked between foes, continued between horses in midstretch, found the fence in the final furlong and picked up the show. M ONE RIFLE sped to the early lead, set the pace a bit off the rail then dueled outside the winner to upper stretch and weakened in the final furlong. NEW BAY well placed stalking the pace off the rail on the backstretch and turn, came out three deep into the stretch and also weakened. FANTASY FREE hopped a bit in a slow start, saved ground chasing the pace throughout and lacked the needed rally. BESTDRESSED broke a bit slowly, settled off the rail, came out into the stretch and failed to menace.
