WORLD OF TROUBLE slightly bobbed at the start then set the pace from the outset, shifted into the four path entering the lane and drew away late in the stretch under a steady drive. SMART REMARK chased the pace early, fanned into the eight path entering the lane, had a late gain in the stretch but was much too late arriving to the wire for the winner. CHAOS THEORY trailed the field early on, shifted into the three path in the turn, made a bid down the lane but flattened out late in the drive. UNRAFTED was back early on, raced widest into the lane while losing ground, came again under a rally down the lane and was gaining in the late stages. ANGASTON was bumped at the start, tracked the pace early, swung into the six path in the turn and weakened late in the stretch run. WILL CALL stalked the pace early, fanned into the seven path in the turn and faded late in the stretch drive. JAZZY TIMES was tugged along the inside fairly close up, fanned into the five path in the turn and was empty down the lane.
