WAR DANCER , three wide between horses most of the opening mile, advanced nicely leaving the far turn, floated to the four path entering the stretch, gained the lead outside foes approaching the sixteenth pole, then dug in stubbornly under brisk urging to last. CHARMING KITTEN saved ground in a stalking position, hugged the rail entering the stretch, briefly steadied in close quarters inside REDWOOD KITTEN in midstretch, found room inside that one during the drive and closed gamely to just miss. JACK MILTON saved ground, was lightly steadied in close quarters entering the far turn, advanced in the two path in upper stretch, altered course to the outside approaching the sixteenth pole then quickly closed outside the top pair. DRAW TWO lacked speed, was two wide between horses turning for home, bumped with FEAR THE KITTEN when angling out for room in midstretch, raced on his left lead and rallied mildly. REDWOOD KITTEN saved ground setting the pace, came out to the two path near the eighth pole and gave way in the drive. FEAR THE KITTEN , five deep on the first turn, advanced five wide leaving the backstretch, was finished with his move in upper stretch, bumped with DRAW TWO in midstretch and weakened. READYSHAKEGO lacked speed, saved ground most of the race and failed to be a factor. RYDILLUC chased the pace outside REDWOOD KITTEN , had aim on the lead entering the stretch, gave way approaching the eighth pole and was briefly steadied on a rival's heels near the sixteenth pole. GEFESEST , four wide around the first turn, was steadied in traffic leaving the backstretch, steadied in close quarters approaching the stretch then gave way. BETHEL , outrun, was wide leaving the far turn.
