HILDA'S PASSION stumbled at the start, recovered and moved up willingly to assume the lead, sped away under a snug hold, left the backstretch, with a clear advantage two wide, continued to carve the pace uncontested during the run around the bend, turned for home having drifted into the three path, was let out a notch and drew away. CURLINA gave chase three wide down the backstretch and early on the turn, worked her way over to the inside, securing that position midway on the turn, proved no match for the winner, but continued on with good courage to be second best. TIDAL POOL well off the inside throughout the turn, spun from the four path into the stretch under encouragement and got up for the show. STREAKER the first to pop out of the starting gate, was out sprinted early, raced between rivals on the turn, got called upon but lacked the needed response. ERIN ROSE was taken quickly over to the inside, cut the corner into the stretch having already been asked for run, but failed to muster up a solid closing punch.
