The purse to be divided: 60% to the winner, 20% to second, 10% to third, 5% to fourth, 2% to fifth, 1% to sixth, 1% to seventh, 1% to eighth. Weight: Three-Year-Olds 122 lbs.; Older 124 lbs. Non-winners of a Sweepstakes of \$60,000 three times at a mile or over in 2014, allowed 3 lbs.; Of a Sweepstakes of \$60,000 twice at a mile or over in 2014, 5 lbs.; Of a S weepstakes of \$60,000 once at a mile or over in 2014, 7 lbs.; Of two races other than maiden or claiming or restricted allowance at a mile or over in 2014, 9 lbs. (No Canadian Bred Allowance.) Final entries to be made through the entry box at the closing time then in effect for overnight events. A supplemental nomination may be made no later than the time of final entry, by a non-refundable fee of \$3,000, which includes the entry fee (Closed with 22 Nominations plus 1 Supplement). *Plus up to \$22,575 Ontario Sired/Ontario Bred Breeder Awards. TURKISH stalked the pace, bid into the final turn, dueled briefly and shook clear then held under a steady drive. ROYAL BLESSING, herded at the outset, settled off the pace, closed angling two to five-wide through the final turn, rallied, came in with a furlong to run then finished all out. PENDER HARBOUR, in range, chased four-wide on the final turn, was steadied when he lost his path a furlong out then chased in deep stretch. DESVELO (ARG) broke inward, settled in midpack, chased two-wide late turn then finished determinedly inside. COZY KITTEN settled off the pace, was hustled on the last turn, angled out in the stretch and finished gamely in vain. MANIGHAR (FR) raced in midpack, closed the first time through the stretch, stalked the pace, chased three-wide on the far turn but evened out in the stretch. BINGO KITTEN settled off the pace, saved ground on the final turn but lacked a rally. QUIET COUNTRY stalked the pace, inherited the lead on the first turn, set a reserved pace, was joined at the final turn, was headed midturn, chased to the stretch and tired. MARATHON RUN led quickly, set a reserved pace, was pulled up on the first turn and then vanned off. A STEWARDS' INQUIRY INTO THE FINAL STRETCH RUN AND A CLAIM OF FOUL BY THE RIDER ON PENDER HARBOUR AGAINST ROYAL BLESSING FOR INTERFERENCE IN THE STRETCH RESULTED IN ROYAL BLESSING BEING DISQUALIFIED AND PLACED THIRD.
