**1 $\frac{1}{2}$  MILES. (Turf) (1.40<sup>1</sup>) STAKES.** Purse \$150,000 *PIN OAK VALLEY VIEW S. (GRADE III) FOR FILLIES, THREE YEARS OLD.* By subscription of \$100 each which should accompany the nomination or by Supplementary Nomination of \$7,500 by time of entry (Includes entry and starting fees). \$750 to enter and an additional \$750 to start, with \$150,000 guaranteed, of which \$90,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of a graded or group stakes on the turf in 2011 allowed 2 lbs.; \$45,000 twice at a mile or over on the turf in 2011, 4 lbs.; three races other than maiden or claiming, 6 lbs. The maximum number of starters for The Pin Oak Valley View will be limited to twelve, with two also eligibles. In the event that the race overfills the starters will be determined at that time with preference given to graded or group stakes winners, then highest 2011 earnings. Starters to be named through the entry box by the usual time of closing. A gold julep cup will be presented to the owner of the winner. Closed Wednesday, October 12, 2011 with 37 nominations. In the event that this race is taken off the turf it will be contested at One Mile and One-Sixteenth on the main track. (Cloudy 71)

DAISY DEVINE tracked the pace three wide, moved up to engage IN STEP near the three-eighths pole, was rebuffed by that one leaving the second turn, dug in and came again inside the furlong marker, wore down the leader, then was all out to keep the steadily advancing BIZZY CAROLINE at bay. BIZZY CAROLINE settled in hand, came four wide to make her bid, finished well but was unable to reach the winner. IN STEP opened clear to set the pace, turned back the challenge of DAISY DEVINE with three furlongs to run, widened into the stretch, but weakened slightly during the drive and grudgingly gave way. HOLIDAYSATTHEFARM was allowed to settle, swung six wide entering the stretch and was making up ground late. PINCH PIE was allowed to settle, came four wide and finished with a mild rally. DYNAMIC HOLIDAY settled saving ground, angled out five wide leaving the second turn but lacked a response when called upon. SAFE CROSSING was snatched back at the start and anchored at the tail of the field, moved out six wide and finished with a belated gain. BARBIES M was unhurried into stride and was never a factor. CHRISTMAS COVE contended along the inside through the second turn and stopped. MAID OF HEAVEN was hustled along three wide, but came up empty between horses after six furlongs and dropped out.
