ANGEL TERRACE hopped at the start to get away behind her field, was unhurried into stride along the inside, moved up through the second turn, shifted out and weaved through traffic through the drive, poked her head in front inside the sixteenth marker and was fully extended to narrowly prevailed. MISS CATO (GB) was reserved early under a snug hold, tugged her way forward between horses, wheeled to the outside leaving the second turn, kicked on well but missed by the narrowest margin. ZAPPER BELLE tracked the pace three wide, forged command entering the stretch, was unable to match strides with the top two but stayed on to earn the show. COSMIC ENERGY stalked the pace four wide, drew even near the five-sixteenths pole, but weakened between horses in the drive and gave way. COLONIAL FLAG was allowed to settle, came seven wide and improved position through the stretch. MEDOLINA was rank to place between horses, leveled into stride on the backstretch, moved up five wide to make her bid between horses but flattened in the final furlong. ANN OF THE DANCE was unhurried into stride, tucked in to save ground, shifted out and finished with a belated gain between rivals. CLOSING RANGE was forwardly placed along the inside, got through entering the stretch but lacked a response when called upon. VOLCAT opened clear to set the pace off of the inside, was collared leaving the second turn, disputed the issue to the final furlong and faded. ALAURA MICHELE was hustled along five wide, offered a mild bid after six furlongs but failed to sustain the drive. NAYARRA (IRE) contended between horses through the second turn and dropped out. RUN A RISK was forced wide leaving the first turn, made a middle move to close the gap but came up empty after six
