The NYRA added money and all fees to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. WAR FRONT moved out along the backstretch, stalked the pace to the far turn, accelerated to the front while four wide on the turn, took charge in upper stretch, extended his lead in midstretch then drew away under steady pressure. **JUDITHS WILD RUSH** bumped in the early stages, saved ground along the backstretch, moved out on the turn, angled five wide at the quarter pole then closed late to best the others. **MASS MEDIA** was bumped off stride while in tight between horses in the early stages, moved to the outside along the backstretch, raced well back for a half, swung six wide entering the stretch and rallied belatedly in the middle of the track. **AFRASHAD** dueled along the inside on the backstretch, relinquished the lead to the winner on the turn and steadily tired thereafter. **BISHOP COURT HILL** pressed the pace between horses to the top of the stretch and gave way. **THUNDER TOUCH** trailed to the top of the stretch, angled wide in upper stretch and lacked a strong closing bid.
