MAJESTICPERFECTION broke in but was away alertly, quickly assumed command with an impressive showing of speed, dictated terms while well off the rail, continued in control while two to three wide on the turn, responded strongly when asked a bit entering the stretch, powered further ahead into the final furlong and proved much the best under a strong hand ride. BIG DRAMA bumped with a rival at the start and was turned sideways, recovered well and tracked the leader on the outside, remained on hold while three to four wide on the turn, was asked to pursue the winner approaching the quarter-pole, failed to match strides with that rival into the final furlong but outfinished BRIBON for the place. BRIBON (FR) was allowed to settle at the rear of the compact field, came under light urging while two then three wide on the turn, moved between rivals approaching the quarter-pole, swung five wide into the stretch and was outfinished for the place. GAYEGO came out at the start and brushed with MAMBO MEISTER then was taken up a bit, settled on the inside, was roused while still inside midway through the turn, saved ground into the stretch and failed to rally. TEMECULA CREEK was bumped on both sides at the start, settled just off the pace, went two to three wide on the turn, drifted inward in upper stretch and came up empty. MAMBO MEISTER bumped with a rival at the start and was brushed by GAYEGO, moved up to race just behind the leader, raced just off the rail on the turn, was carried inward in upper stretch and tired while drifting out in the final furlong. SMOKEY FIRE settled on the outside, was ridden along while four wide on the turn and faded.
