Chestnut Filly, (Maj), by Hennessy - Sous Entendu by Shadeed. Trainer Duggan P. David. Bred by Gainsborough Farm LLC(KY). PORTE BONHEUR steadied briefly between horses at the five-eighths pole, was rated between horses for a half, split rivals at the quarter pole, made a run to challenge nearing the sixteenth pole and edged clear in the final fifty yards. INDYANNE lunged at the start, trailed early, steadied briefly along the backstretch, rushed up inside to contest the pace at the half mile pole, dueled along the rail to the top of the stretch, opened a clear advantage in upper stretch, battled into deep stretch and yielded grudgingly. INFORMED DECISION broke a bit slowly, saved ground for a half, launched a rally along the rail in upper stretch and finished willingly to gain a share. PALANKA CITY steadied briefly on the backstretch, angled in on the far turn, rallied along the rail to reach contention in upper stretch and flattened out late. J Z WARRIOR dueled outside for a half and gave way. SLY STORM failed to mount a serious rally while four wide.
