EXCITED stalked the pace three wide, inched closed while still three wide around the far turn, took a slim lead nearing the eighth pole, edged away on her left lead and prevailed. SUMMER SAVORY stalked the pace from the rail, waited for room from the quarter pole to the eighth pole and surged inside once finally clear to just miss. WYOMIA bumped with DYNAMIC HOLIDAY and PINK PALLET just after the start, disputed the pace two wide, dug in when initially confronted by the winner near the three-sixteenths pole, dueled inside that foe to the sixteenth pole and was out kicked from there. SMART STING settled off the pace while racing three wide early, came four wide around the far turn, shifted further out in upper stretch and rallied. DYNAMIC HOLIDAY bumped with WYOMIA just after the start, stalked the pace two wide between rivals, bid between in upper stretch but was out kicked in the final furlong. PINK PALLET bumped with WYOMIA just after the start, was unhurried while saving ground, swung to the extreme outside turning for home and finished well. MYSTICAL STAR vied inside of WYOMIA to upper stretch and weakened in the drive. SASSY'S DREAM pulled while rated along in the two path early, moved three wide around the far turn and lacked the needed rally.
