REPRIZED STRIKE settle behind the early leaders, circled three wide off the far turn, surged clear then remained under strong handling to prevail. DE ROODE raced four wide into the first turn, was two wide along the far turn then closed willingly late for the place. JOMA was unhurried just off the rail, made a four wide move into the stretch then continued willingly to earn a share. TOTALLY DEDICATED chased two wide early, was along the rail around the final turn then finished evenly. BLUSHING CHARLIE three wide early, was in contention to the stretch and was outfinished final furlong. VERY VERY SNEAKY up close two wide, loomed into upper stretch, weakened. ITSAWONDERFULIFE five wide early, three wide along final turn, weakened. FIFTY SEVEN G sent to command inside, dueled into stretch, tired. NOT ON MY TURF chased saving ground, eased out into stretch, tired.
