1 3/8 MILES. (1.541) STAKES. Purse \$300,000 WASHINGTON PARK H.(GRADE II) FOR THREE-YEAR-OLDS AND UPWARD. By subscription of \$200 each, which should accompany the nomination. A Supplementary Nomination of \$10,000 may be made on Saturday, July 22, 2006, which includes entry and starting fees. Original nominees to pay \$2,250 to pass the entry box and an additional \$2,250 to start, with \$300,000 Guaranteed, of which \$180,000 to the winner; \$60,000 to second; \$33,000 to third; \$18,000 to fourth and \$9,000 to fifth. WEIGHTS: Sunday, July 23, 2006. This event will be limited to four (4) starters. Preference will be Highweights (on the scale). *Total Earnings in 2006 will be used to determine the order of preference of horses assigned equal weight (on the scale). Failure to draw into this race at time of entry cancels all fees with the exception of the nominating fee(s). Starters to be named through the entry box by usual time of closing. Two (2) horses having common ties through ownership cannot start to the exclusion of a single ownership interest. Trophy to the owner of the winner. Closed Wednesday, July 19, 2006 with 16 nominations.

SUAVE settled in stalking the pace from off the rail, moved up to challenge turning for home, took the lead in the stretch and drew off while kept to his task. PERFECT DRIFT saved ground near the middle of the field and gained ground in upper stretch but could not threaten the winner in the late going. SECOND OF JUNE raced in good position off the rail but could not gain when asked for a late response. NOLAN'S CAT trailed early then could only improve his position without threatening. O'CONNELL'S (BRZ) bobbed at the break then could never reach a contending position. IOSILVER set the pace from the inside on a clear lead and was tiring when checked in upper stretch. THREE HOUR NAP was rank in the post parade and was pulled up at the half mile pole and vanned off.
