A supplemental nomination fee of \$750 in addition to the entry and starting fees may be made at any time prior to the closing of entries. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. 122 lbs. Non-winners of \$36,000 other than restricted stake allowed 2 lbs.; two races, 4 lbs.; a race other than maiden or claiming, 6 lbs. A trophy will be presented to the winning owner. KING AND CRUSADER away in good order, sat patiently parked three wide for the opening half, entered the stretch and was given his cue, made a successful bid outside the front runners to take over just prior to the eighth pole, kicked away but soon felt the presence of his stable mate, fended that one off under a brisk hand ride. **RESERVED QUALITY** unhurried during the initial stages, unleashed a run from the three-eighths pole, moved outward gradually, eventually spinning from the four path into the stretch, closed in with good energy en route to being second best. **DELIBURNKY** pressed the issue from two path almost from the get-go, got asked for a response nearing the five-sixteenths pole, turned for home abreast of **YO KOFFY**, was in the midst of a duel with the previously mentioned opponent when the winner arrived on the scene, fell back when unable to keep pace. **YO KOFFY** argued for control from the rail, entered the stretch with **DELIBURNKY** latched on to his hind quarters and was soon let out, held his ground well for an additional furlong before backing away. **DONE DONE DONE** raced along the outside, was put to a prolonged drive, but made no headway on the front runners. **HE CAN RUN** displayed brief foot, was eased coming to the eighth pole and vanned off.
