**CURLIN** moved up between horses, was carried out by **DIVINE PARK** and brushed with **OUT OF CONTROL** on the first turn, raced in the four path while being brushed again at the five-eighths pole, rapidly closed the gap three wide to reach contention nearing the quarter pole, drew on even terms with **PAST THE POINT** at the furlong marker then gradually edged away under steady right hand encouragement. **PAST THE POINT** sprinted clear soon after the start, set the pace along the inside for five furlongs, extended his advantage midway on the turn, maintained a narrow lead approaching the furlong marker, dug in when challenge in midstretch then yielded grudgingly while holding gamely for the place. **WANDERIN BOY** pressed the pace from outside to the far turn, dropped back slightly on the turn, fought back in upper stretch, remained a factor into midstretch and weakened late. **A. P. ARROW** saved ground for seven furlongs, swung five wide at the top of the stretch and lacked a strong closing bid. **LOOSE LEAF** lunged at the start and failed to threaten while between horses. **DIVINE PARK** drifted out causing crowding on the first turn, bumped the winner while four wide along the backstretch, ducked in on the turn then gave way. **OUT OF CONTROL (BRZ)** was bumped and carried wide on the first turn and gave way after going five furlongs.
