EVENING JEWEL set the place off the rail, repulsed a bid by PROTESTING on the second turn, increased her lead into the stretch then lasted late under steady urging. IT'S TEA TIME steadied nearing the first turn behind and inside a rival, was reserved while saving ground, commenced her rally near the rail on the second turn, angled out a bit near the sixteenth marker and finished well to be rapidly gaining on the winner late. SHE BE WILD close up along the inside, angled out approaching the stretch but went evenly late. PROTESTING forwardly placed three wide, made a run at the winner on the second turn, pressured that one to the final quarter and tired. UPPERLINE outrun while off the inside, improved her position while no threat. APPLE CHARLOTTE steadied in the initial furlong in traffic, was reserved for a half, raced in the three path on the second turn and could not threaten. NEGLIGEE within striking distance three wide, moved out a path on the second turn but gave way in the drive. BEAUTICIAN forwardly placed off the rail, faded.
