BRODY'S CAUSE was unhurried early along the four path, swung into the six path in the far turn, kicked on and rallied entering the lane, drove past the leader and cleared the field in the final stages. EXAGGERATOR was well placed early, made a bid nearing the quarter pole, split horses entering the lane, took over command and drew clear in the stretch but yielded late in the drive. RATED R SUPERSTAR pressed the pace early from the inside, shifted into the four path in the far turn and flattened out late in the stretch run. STICKSSTATELYDUDE stalked the pace early from the five path, stayed in the five path in the far turn while making a bid but leveled out late in the stretch drive. UNCLE VINNY was back early, angled off the rail into the far turn, shifted outside nearing the three sixteenth pole and moved up late in the drive. SHEIKH OF SHEIKHS set the pace early, angled off the rail into the far turn and gave way in the stretch. THREEFIVEINDIA chased the pace early along the five path, shuffled back late in the backstretch, swung into the six path in the far turn and was empty late. UNCLE JERRY hopped at the start while no factor. GAMETOWN tracked the pace early from the four path and was tired in the stretch. PINNACLE PEAK broke awkwardly and was done early. WILD MAN was through after a half.
