For horses not originally nominated, a supplemental payment of \$3,000 along with the entry and starting fees may be made at any time prior to the closing of entries. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. 121 lbs. Trophies will be presented to the winning owner, trainer and jockey. Closed Saturday, July 11, 2015 with 24 Nominations. (Clear 80)

Chestnut Filly, (May), by Curlin - Whatdreamsmadeof by Graeme Hall. Trainer Todd A. Pletcher. Bred by CASA Farms I, LLC (KY).

I'M A CHATTERBOX was away well from the outside post, dropped in while going to the front, set the pace through solid fractions while near the rail, controlled the action through the far turn, responded well when put to a right-handed whip in upper stretch, clung to a lead into the final sixteenth, drifted out late then brushed with CURALINA and just held. CURALINA bumped with rivals at the start, moved out early then jostled with CONQUEST ECLIPSE, went three then two wide on the first turn, raced just off the pace, chased two to three wide on the far turn, came under a right-handed whip in upper stretch, switched to a left-handed whip nearing the furlong marker, pursued the leader into the final furlong, was carried out late then brushed by the winner and just missed. INCLUDE BETTY was bumped at the start then forced into another rival and in a touch tight, raced in the two path on the first turn, lagged at the rear, was urged along while three wide on the far turn, negotiated her way past a stopping rival at the five-sixteenths, swung five wide into the stretch, gained ground under a strong drive and finished willingly to just get the show. DANETTE raced inside on the first turn, settled near the back, was urged along in the two path on the far turn, swung four wide into the stretch, was put to a right-handed whip after straightening for the drive, switched to a left-handed whip outside the furlong marker, gained ground on the inside of INCLUDE BETTY and also finished willingly but just missed the show. CHIDE was bumped lightly in the hindquarters at the start, settled on the inside, was urged along while along the rail on the far turn, saved ground into the stretch, moved out while under a drive and failed to threaten. KEEN PAULINE broke in and bumped with INCLUDE BETTY, raced off the rail early on the first turn then dropped to the inside, was well placed just off the pace, passed the five-eighths pole under coaxing, chased inside on the far turn and tired. CONQUEST ECLIPSE was bumped on both sides at the start then in tight, jostled with CURALINA early, went four then three wide on the first turn, stalked the pace on the outside, dropped back under urging leaving the backstretch, came up empty while three to four wide on the far turn and stopped then was eased in the final furlong but walked off. Following a stewards' inquiry and claim of foul by the rider of CURALINA, I'M A CHATTERBOX was disqualified from first and placed second for interference nearing the wire.
