AGELESS was unhurried early, swung into the six path in the turn, rallied in the stretch and was up late, vanned off after the race. LADY SHIPMAN pressed the pace early, fanned into the five path in the turn, continued to drift out upper stretch while clear and was ran down at the wire. FREE AS A BIRD was back early, shifted into the four path in the turn with a mild gain in the stretch run. SWEET NKOSI was reserved early, swung into the six path in the turn with some gain in the stretch drive. ELUSIVE HOLIDAY chased the pace early, fanned into the five path in the turn and flattened out late in the stretch. RICHIES SWEETHEART set the pace early, shifted into the three path in the turn and gave way late. FLEET ENCOUNTER was never involved. EKATL'S PHAETON was through after a half.
