Purse \$200,000 Florida Sire Dr. Fager S.COLTS AND GELDINGS, TWO YEARS OLD, THAT ARE FLORIDA SIRE STAKES NOMINATED. \$1,250 to pass the entry box and \$750 additional to start, with a purse of \$200,000. 60% of the purse to be distributed to the owner of the winner, 20% to second, 11% to third, 6% to fourth, 3% to fifth. All starters will receive a \$1,000 rebate. Weight: 118 lbs. Starters to be named through the entry box by the usual time of closing. All fees shall be paid prior to the start of the race. This race will be limited to 12 starters, with also eligibles. If more than 12 entries pass the entry box preference will be given to horses with highest career earnings. Trophy to the Winning Owner. (Cloudy 90)

DREAM OF ME hustled up and vied for early lead arcing along outside of MR KISSES, dug in between rivals at quarter pole, squeezed back in turn, angled to inside top stretch and kicked clear under driving finish. MR. KISSES dueled for the lead racing along the inside of DREAM OF ME, continued to match strides at quarter pole, shifted out path in turn, had slight lead a furlong out, began to drift out, encouraged right handed, could not hold off DREAM OF ME and continued to drift out nearing the wire. BRIGHTON LANE was unhurried in the backstretch, began to pick up pace approaching turn, raced five wide top stretch, angled to inside, quickly gained ground and moved up to capture show. LIL MEATBALL raced up close and tracked top two leaders, moved up to challenge rival, dueled three wide at quarter pole, dropped whip top stretch and flattened out in final sixteenth. FELLOWSHIP was allowed to settle off pace in backstretch, saved ground along inside, cut corner into head of lane, urged along rail and needed more to threaten the leaders. DANBURY raced in contention placed off the top trio, hustled up in turn, dug in four wide at head of lane, failed to move on and finished evenly. GRAPHITE STRIKE rated back off pace in backstretch, dug in four wide in turn, continued outside bid and lacked needed kick to move into contention. TITLE FIGHT angled to rail steps after start, kept along inside, raced in tight and steadied approaching the half, continued reserved near the back and lacked response in the lane. FLASHING LIGHT raced along outside, bolted in turn and was eased up in stretch.
