All Breeders' Cup pre-entered horses will automatically be nominated. No Fee. By subscription of \$200 each if made on or before Thursday, October 19, 2017 or by supplementary nomination of \$2,000 at the time of entry. All horses to pay \$500 to enter and an additional \$2,500 to start, with \$200,000 guaranteed. The winner to receive \$120,000, \$40,000 to second, \$24,000 to third, \$12,000 to fourth and \$4,000 to fifth. Weights: Three-Year-Olds: 122lbs. Older: 125 lbs. Non-winners of a Gr. I or Gr. II race at One Mile or Over since May 1, 2017 allowed 2 lbs.; Non-winners of a Gr. I or Gr. II at One Mile or Over since November 3, 2016 or a Grade III race at One Mile or Over since June 1, 2017, 4 lbs. High weights preferred. Second preference to horses Gr. placed in 2017. Third preference determined by 2017 non-claiming earnings. The field will be limited to 14 starters. Starters to be named through the entry box Monday, October 30 by the closing time of entries. KITTEN'S ROAR angled in and stalked a bit off the rail then inside, came out into the stretch, bid outside the pacesetter to take the lead in midstretch and won clear under some urging. THUNDERING SKY in a bit tight into the first turn, saved ground stalking the pace, came out in midstretch and edged foes for second three deep on the line. ON LEAVE saved ground stalking the pace, came out past midstretch and split foes for the show. MALIBU STACY sped to the early lead, set the pace inside, fought back past midstretch and was edged late for third. LASEEN (IRE) pulled and was in tight nearing the first turn, chased inside, came out into the stretch and again past midstretch and bested the others. MAJESTIC HEAT pulled early, angled in and chased between horses, continued outside a rival into the stretch and lacked the needed rally. ALJAZZI (GB) a step slow to begin, angled in and settled outside a rival then a bit off the rail, came out into the stretch and could not offer the necessary late kick. CORPS DE BALLET chased three deep to the stretch and lacked the needed rally. MRS MCDUGAL angled in and stalked between horses, was blocked off heels from upper to midstretch and could not offer the necessary response. HILLHOUSE HIGH close up stalking the pace outside a rival, came three deep into the stretch and weakened. MADAME STRIPES (ARG) chased outside, went four wide on the second turn and five wide into the stretch and did not rally. SASSY LITTLE LILA had speed four wide then stalked a bit off the rail to the stretch and weakened between horses. LAUR NET unhurried early, saved ground off the pace to the stretch and did not rally. GOLDY ESPONY (FR) stalked three deep then outside a rival, went three wide into and on the second turn and four wide into the stretch and weakened.
